#### County Access Fees

Some county courts charge a fee to release a copy of their court records. In these instances, we will pay for these fees up front in order to obtain the records, and then bill you for the fee on your next invoice. A County Access Fee list can be found at [ProScreening.com/fees](https://www.ProScreening.com/fees). It is the responsibility of the client to be aware of potential fees.

#### Multi-State Database Search

The InstaCriminal Multi-State Alias Search is a database containing millions of criminal records from thousands of jurisdictions across the country. If a crime was committed outside of the counties where someone has lived, this database is your best chance at finding it. If a criminal hit is found in the Multi-State Database Search, it's our policy to pull the County Criminal record to obtain all available information to ensure the record being reported is accurate and up-to-date. This helps to fulfill our reporting requirement of maximum possible accuracy. If you aren't currently including this in your background checks – you should be.

#### National Sexual Offender Registry Search

Includes all offenders currently registered with the National Sex Offender Registry.

#### SSN Trace

Using the SSN of your applicant, we examine the name and address history of your applicants to determine the best name(s) and jurisdiction(s) to search for criminal records during the past seven years. ProScreening utilizes this information internally only, so this data will not be reported on the final report to you.

#### Alias Search

Our SSN Trace will search for and disclose Alias names that have been used in conjunction with the Applicant's SSN. This search is automatically included as part of our InstaCriminal Multi-State Search. Any alias names found will automatically be searched for criminal records in this database.

#### County Criminal Record Search

County Criminal Court Records are where the most thorough and up-to-date criminal case information is stored. A county search will typically disclose convicted Misdemeanor and Felony records, as well as the: jurisdiction, type of offense, offense description, case number and case disposition.

#### Federal Court Records

Federal criminal, civil or bankruptcy searches can identify records such as interstate drug or arms trafficking, identity theft, embezzlement, kidnapping or crimes that occur on Federal property. These records are especially useful for management & financial positions.

#### Motor Vehicle Reports (MVR)

### Types of Verifications

Employment Verification: Attempts to verify dates of employment, position, salary, reason for leaving, and potential re-hireability.

Education Verifications: Verify dates of attendance, areas of study and degrees obtained.

Professional License Verification: Verifies professional licensure and standing.

DOT Verifications: Can be performed for anyone applying to a DOT regulated position in compliance with FMCSR laws. Both Safety Performance and Drug and Alcohol History are verified.

\*\*Third Party Fees -- At times employers use third party verification systems to outsource verifying employment. At setup you choose whether or not you want us to still perform verifications that require these additional fees.\*\*

### Drug Testing Information

1. You place the order for a drug test.
2. We find the facility! Using the applicant's home address, we find the clinic that is closest to them from our Nationwide Network.
3. An email is automatically sent to the applicant telling them what facility to go to for their drug test, what to bring with them, and how long they have to complete the test.
4. Our eCup test will deliver negative results the same day.
5. Any Medical Review Officer (MRO) fees are included in the cost of the test.
6. We pay the labs and clinics and simply invoice you with your Background Checks.

#### 4-Panel X Cup

4-Panel xCup Test Includes Cocaine, Amphetamine, Opiates, Phencyclidine (PCP).

#### 5-Panel Test

Cannabinoids (THC), Cocaine, Amphetamine, Opiates, Phencyclidine (PCP). Rapid 5 Panel Tests available as well as lab processed tests.

#### 10-Panel X Cup

Tests for Marijuana, Cocaine, Amphetamines, Morphine 2000 Methamphetamines, PCP, Barbiturates, Benzodiazepines, Methadone, Propoxyphene. Negative results are returned to the client in about 10-15 minutes. Positive results are sent to the MRO (Medical Review Officer) for review before reported to the client
